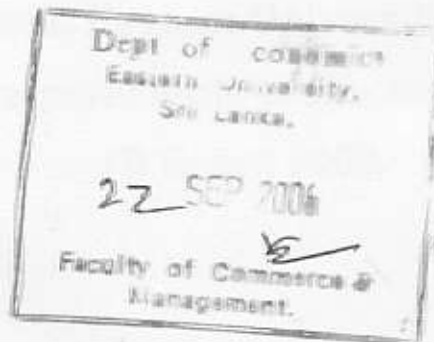


**ROLE OF NGOs ON IMPROVING STANDARD OF LIVING
