ABSTRACT.

The fishing industry is playing the vital role in the Sri Lankan economy and provide the employment opportunities, nutrition, foreign exchange earning and improve the income generation of the coastal areas. Due to the several reasons, the fisheries sector have to be develop for increase the income generation of the peoples.

The fisheries sector is very important to increase the income generation and poverty alleviation in the Koralai Pattu South D.S Division in Batticaloa District. Most of the peoples engaged in fishing activities for their main source of income.

The objectives of this study is to identify the problem existing in this sector, to identify the suitable development programme to overcome the problems, to identify the institutional activities to improve the socio economic status of the fishermen and also formulate the development plan for fisheries sector. The research investigation is based on the conceptual framework. 100 questionnaires were issued to the fisheries families with the simple random sampling method.
