ABSTRACT

This study was measuring "Study on the social and livelihood development of the people of Thikiliveddi village through rehabilitation, special reference to NGO project". The Thikiliveddi village social and livelihood condition was very low level before the project implemented by NGO. But after the Project implemented, the effectiveness of project on social and livelihood was not analyzed. This research was carried out in order to find out the effectiveness of project in social and livelihood condition of this village residence and find out the current needs of this community regarding social and livelihood development. Through this finding, propose solution for further improvement of this village.

The variables included in this study were social factors and livelihood factors. To measure these variables data was collected from a sample of hundred residents from Thikiliveddi village using random sampling technique. The collected data were analyzed using the univariate method. The collected data were presented in the form of tables, bar charts and pie charts. The data gathered were analyzed using the Microsoft package excel 2000 and SPSS 11.0 windows.

The findings showed that, most of resident improved in social and livelihood. The improvement highly took place in basic needs and marketing which come under the social factors and livelihood factors respectively. Education and employment also has developed to certain level at the same time, general facilities, health and sanitation, resource utilizations have to be developed.

Therefore it is recommended that the basic requirement of this village people should be developed without delay to this village get development in this region.
