## ABSTRACT.

Education will control the miner age marriage and that will limit the young widows numbers. To give the clarification of their traditional, Religious and culture Values awareness programme should be carried out. The NGOs should not stop giving training only they must help widows to find jobs.*

*When widows selected for employment training educational qualification should be considered For an example: GCE (A/L) qualified widows can be given computer training short hand, typing training. The other low qualified people can give handy craftworks. The loan supplied to utilize certain projects should not be used for other field or needs. To monitor this, NGOs should visit visit the recipient place and observe the project works.*
