ABSTRACT

Health is a most important aspect peoples' life. So it should be considered at part of the life. Today, it has been challenging for people in view of improving the peoples' health status especially for those who are in the developing nations. The contribution of government and non government organizations are highly expected by the people for the empowering them to face this challenge. In this way World Vision contribute a lot to the people to improve their health status in the division of Eravur Pattu. To make sure whether that activities have change the peoples' health status or not and also to know the reason for it, the research study was carried out. The objectives of this research study are identifying the present health status of the people in Eravur Pattu, to find out the contribution of world vision to improve the heath standard in society and to suggest some activities for the future development of health. Based on the objectives, the conceptualization framework for this research has developed. It includes four variables such as Health education, Health centers, Nutritional status and Water and sanitation. In the sequence of conceptualization framework, the statements in questionnaire were arranged, where pre selected set of statements was issued to the respondents in order to collect reliable data. The five point Likert scale model of statements were used, which are ranking from one to five. The questionnaires were issued to 200 World Vision health beneficiaries by random sample basis but 150 questionnaires were only collected from respondents.

The over all evaluation of 150 respondents of World Vision beneficiaries following results have been received. All the variables derived from the data reveal that the people were moderately satisfied by the World Vision contribution in Health education and Health centers, Nutritional status is in low level of satisfaction and the Water and Sanitation facilities provided by the World Vision is in highly satisfactory level. So the overall analysis includes that the World Vision contribution toward improvement of health status is in moderate satisfactory level. Therefore it concludes the world vision activities having a capacity to change the health status of people.
