#### ABSTRACT



The research study has intended the title "A Study on work related Disciplinary Management practice in Banks in Batticaloa District." The objectives of this research are measuring the extent to what the disciplinary management problems is handled among banks employees in Batticaloa district.

The conceptualization of the study has four variables such as Disciplinary Management practice on Attendance problems, Work performance problems Dishonesty related problems and on-the job behavior.
